

Students are required to pay fees according to the scheduled dates. An NOC (No Objection Certificate) will be obtained from the official fee payment partner after the completion of the course. Only upon receiving the NOC will students be issued their original PG Diploma Certificates and Industry Certifications.

Important Note:

The fees charged to students are for the Post Graduate Diploma in Quality & Industrial Engineering Skills (Work Integrated Skill-based Higher Education- WISE Model: On-The-Job Training). This program is Recognized by UGC & accredited by the National Council for Vocational Education and Training (NCVET) and aligns with the National Skills Qualifications Framework (NSQF) and the National Credit Framework (NCrF) as well as international organizations like ASME, ASNT, and AWS.

Since you have opted for company sponsorship, the sponsorship amount deposited into the student's account, along with the stipend, will be repaid to Synergem in monthly installments. The repayment will be facilitated through the ECS auto-debit system.

TERMS & CONDITIONS

1. Admission form must be filled in with due care by the students. Any change in residential address, mobile numbers, etc. should be informed to the institution in writing duly signed by student (changes would not be accepted over phone, SMS & Email).
2. Documents mentioned above should be submitted by student at the time of admission. Synergem will conduct training as per the international standards & Norms.
3. Students should gain marks in examination as per standards of international bodies.
4. Student will eligible for placements & Certifications only after clearing 100% of the course fees.
5. Discipline and ethics are the basic needs laid by companies. Any misbehaviour/ misconduct by the student/ parent/ guardian will lead to rustication of the student with immediate effect
6. Student should attend minimum 90% of classes in overall scheduled classes
7. Students will get placement guarantee under the program. Details of the same are stated below
 - On-The-Job Training will be provided in our client companies which are available in Pan India. Accommodation, Transportation and other expenses should be borne by student.
 - Job location and posting is provided by the company as per openings available in their projects across India (Pan India)
 - Students performance is mapped by the company during On-The-Job Training, hence student should complete overall 01 Year On-The-Job Training without discontinuation. (Leaves can be utilised as per company terms and conditions)
 - Students can continue working in the same company after completion of 01 year On-The-Job training with hike in salary or switch to a new company by providing a minimum of 60 days' prior notice.
8. Placements & On-The-Job Training updates will be given to students through various communication mediums via Mail, SMS or WhatsApp.
9. Company may provide higher salary to students who perform better during their 01 Year On-The-Job Training. Higher salary offered will be as per company policy.
10. All monetary dues related to academic should be cleared on or before the due dates failing which the institute management is authorised to impose a penalty of Rs. 100 /- per day (holidays would be excluded).
11. Synergem reserves the right to cancel the admission if the fee dues are not cleared in time.
12. Payment must be made in institute current account under name “Synergem Consultancy Pvt Ltd” either in the form of cheque, net transfer, online transfers, POS or cash.
13. Payment once paid will not be refunded in the middle of the course.
14. Student opted for Instalment Option Facility should clear the fees as per the schedule. Any overdue in fees will lead to cancellation of admission or placement provided. No certificates shall be provided in such case.
